Ladies and Gentlemen,

At the dawn of the new decade entrepreneurs are facing the challenge of maintaining their competitive edge. The decisive factor for manufacturing plants will be access to cheap and clean energy from renewable sources. Entrepreneurs powering their facilities with electricity from fossil fuels will pay increasingly more due to rising CO2 emissions prices, and their products can be ignored by ever more environmentally aware customers.

The solution may be the purchase of electricity directly from its generator – a wind or solar farm – under a long-term agreement called a corporate PPA. Over the last several years European companies have used this instrument to contract power from over 7 GW of installed capacity. More global corporations take a step further by declaring a shift to 100% power from clean renewables. Companies associated in the RE100 initiative put the same requirement for their suppliers.

The potential of the corporate PPA market in Poland is enormous. Our industry needs approx. 50 TWh of electricity per year, which is one-third of Poland's total consumption. However, dynamic development of the cPPA market requires removing administrative barriers. Regulatory changes in this respect are one of the goals of RE-Source Poland Hub foundation, established in July 2019 by the Polish Wind Energy Association.
